1. THOMAS⁴ LINDSEY (*JACOB*³, *ELIJAH*², *THOMAS*¹) was born Jan 21, 1791 in Wilkes County, Georgia, and died Oct 02, 1861 in Angelina County, TX. He married BATHSHEBA SUDDUTH Jun 10, 1810 in Wilkes County, Georgia, daughter of JAMES SUDDUTH and NANCY SMART. She was born Jan 17, 1791 in Wilkes County, Georgia, and died Feb 10, 1865 in Brownsboro, Henderson County, TX.

Notes for THOMAS LINDSEY:

Between 1815 and 1821 the Lindsey family moved from Georgia to Tuscaloosa County, Alabama. It appears that at least some of Bathsheba Sudduth Lindsey's family, the Sudduths, also relocated to Tuscaloosa County.

In approximately 1832 Thomas and Bathsheba Lindsey moved to Choctaw County, Mississippi. He was 41 years of age. It is possible that other members of the Sudduth and Beasley families also made the move. Choctaw County was created December 23, 1833 from the Chickasaw Cession of 1832. Thomas Lindsey was one of the first public officials in the county, serving as Probate Clerk. By 1840 thee were only three villages in Choctaw County: Greensborough, Bellefontaine and Springfield. In the book, CHOCTAW COUNTY CHRONICLES (p. 33), the following was stated:

"The following men, chosen in 1834, had the distinction of serving as the first public officials of Choctaw County:

Sheriff - Garrett Neill

Probate Clerk - Thomas Lindsey

Circuit Clerk - P.J. Campbell

Board of Police (Board of Supervisors): William Dyse, William Rogers,

Mont. Hutchins, and J.W. Brandon."

On December 29, 1845 the Republic of Texas ceased to exist and Texas became the twenty-eighth state of the Union. The Lindsey family joined several other families and migrated to Texas in 1845. A large number of the original group who set out for Texas died of cholera on the east bank of the Mississippi River. Apparently two children of Thomas Lindsey died at this time. William Lindsey died. His wife and three children contined the journey. A daughter, Nancy Lindsey Holsomback, a widow, traveling with her two small sons, Jacob Jasper and Thomas Newton, also died. The orphaned boys were reared by Thomas and Bathsheba Lindsey. Thomas Lindsey was 54 at the time of the move to Texas. His son, Thomas Jefferson Lindsey, was 30 years of age.

The first settlers to arrive in the Dialville, Texas area came by wagon train in about 1845. The pioneers chose to build their homes on either side of the Nacogdoches-Neches Saline Road. The new settlement was in a remote location, ten miles from Cook's Fort. Nacogdoches, fifty miles away, was the primary source for supplies. The Cherokee Indians had been driving from

the County only six years earlier.

From "The History of Dialville, Texas" the following information is provided:

"For some time these early settlers held worship services in their homes, but in 1848 they gathered in the home of Thomas Jefferson Lindsey and organized the Rocky Springs Missionary Baptist Church. A roll of its charter members is most likely a list of the majority of the first settlers. At the organizational meeting, Elder Walter Ross was the moderator, and the following people were named as charter members: J.J. Lindsey, Isaac Sheppard, Thomas J. Lindsey, Elizabeth Lindsey, Minerva Crenshaw, Bathsheba Lindsey, Stephen Halbert, John Halbert, Sally Margaret Halbert, Frances Halbert, Wylie Thomason, Thomas Johnson, Lucy Johnson, Gordon Shaffer, and John Harris, an ordained deacon. The Rev. George Washington Slover was chosen as the first pastor. He is buried in the Rocky Springs Cemetery, where a state historical marker has been placed at his grave."

The Texas State Historical Marker located in front of the Rocky Springs Missionary Baptist Church states:

"Organized April 8, 1848, by a group of settlers from this area, in the home of Thomas J. Lindsey, under Elder Walter Ross. The known charter members included Minerva Crenshaw, Frances Halbert, John Halbert, Sally Margaret Halbert, Stephen Halbert, John Harris (an ordained deacon), Lucy Johnston, Thomas Johnson, Bathsheba Lindsey, Elizabeth Lindsey, J.J. Lindsey, Thomas J. Lindsey, Isaac Sheppard, Seary Sheppard, and Wylie Thomason. True pioneers, these people had immigrated to the area just three years earlier, when Texas was admitted to the Union.

The Rev. George Washington Slover, said to have built the Atlanta Hotel depicted in the Civil War Novel "Gone with the Wind", was the first pastor.

Soon after the organizational meeting, a log cabin was erected on the present site to serve as a place of worship. The bubbling springs here and at the Lindsey home probably inspired the church name.

The cemetery originated in the early days of the church. The oldest legible headstone is dated 1849. The original log church building was replaced in a few years by the present structure and in 1950, Sunday School rooms were added to it."

According to Norman Dingmore:

Thomas Lindsey is buried in the Old Rock Hill Cemetery near Brownsboro, TX. In 1951 I saw part of his stone with name and year of birth at an angle in a part of the cemetery from the other Lindsey graves. When I revisited the cemetery in 1980's, no trace of the stone. His estate was probated in Angelia County, Texas; however, an estate could be probated in a county where deceased owned property, and he owned property in Homer, Texas. Thomas Lindsey served in the War of 1812. Enlisted 26 August 1813 at Washington, Wilkes County, Georgia. Served as a Private under Captain John E. Little. He fought at the battle of Horseshoe Bend in Alabama in 1814 with Andrew Jackson. Sam Houston also fought in this battle. Thomas served 6 months and 13 days and was honorably discharged at Milledgeville, Georgia, Marchf 13, 1814. According to tax records, Thomas was still living in Georgia in 1816. On June 26, 1913, about 40 descendants of Thomas Jefferson met at the Old Rock Hill Cemetery to dedicate a new stone at his grave furnished by the government, showing his service in the War of 1812.

Alfred Middleton Lindsey was born March 1, 1837 in Mississippi. It is believed that his father, William Lindsey, died of cholera as the Lindsey families were migrating to Texas in 1845.

Alfred Middleton Lindsey, first cousin to James Marion Lindsey (father of Donie Lindsey Brooks), married Mary Parker in Cherokee County, Texas July 7, 1859 at age 22.

He served as a Private in Co. F, 13th Texas Cavalry during the Civil War, under Hiram John Burnett. He served 3 1/2 years, enlisting during the summer of 1861 and was discharged at the close of the war in Homer, Angelina County, Texas.

1880 Census- Living in the Mercer Community of Bell County, Texas. He lived next to the Daniel Mantooth family and the Samuel and Eliza Malone Brooks Mantooth family. (Eliza Malone Brooks Mantooth was the sister of John Dunn Brooks who would later also move to west Texas.) They were both living in Williamson County, Texas. (Conf. Pension Application 3743).

1901 - Shown as living in Glen Cove, Coleman County, Texas.

1907, March 29 - Applied for a Confederate Pension for a second time (Confederate Pension Application 13533) which was approved. At that time he owned no real property and "only a horse and buggy, value about \$75." He was living in Abilene at the time, age 70. In the application he stated that he had lived in Taylor County since 1895.

He was listed in the City Directory of Abilene, Texas in 1907-08, occupation as "stove repair". He was apparently living with his son, William T. Lindsey, at the SW corner of Pecan and South 9th Street. Living in the house, also, was Miss J. Grace Lindsey. Two other Lindseys were listed in the Directory: Miss Fred Lindsey, a saleslady at Emporium Millinery Co, boarding at 1443 N. 2nd, and Miss Minnie Lindsey, saleslady Minter Company, boarding at 1443 N. 2nd also. These were perhaps daughters of William T. Lindsey and granddaughters of Alfred Middleton Lindsey.

April 28, 1918 - Alfred Middleton Lindsey died at the home of his son, John H. Lindsey, in Loraine, Mitchell County, Texas. Cause of death was shown as "old age". (Death certificates states he died April 27, 1918.) He was buried in the Bluff Creek Cemetery, Taylor County, Texas, next to his wife, Mary, who had died in 1902.

Alfred Middleton Lindsey (1837-1918) was first cousin to James Marion Lindsey, the father of Donie Lindsey, who married John Alson Brooks. It is interesting to note that after his death in 1918, John and Donie Brooks moved to Drasco, Texas, less than 1/2 mile from the Bluff Creek Cemetery where Alfred lived and Moro, Texas, where he owned land. The parents of John Alson Brooks (John Dunn Brooks and Nancy Jane Mantooth Brooks) were living in Loraine in 1913 when John Dunn Brooks applied for his Confederate Pension. They moved from Loraine between 1913 and 1920. Alfred Middleton Lindsey's son, John, was perhaps living in Loraine at the time they were there. It is not known whether or not Donie Lindsey Brooks knew her father's cousin had lived and was buried near where they settled at Drasco, Texas in 1924, living there at the time of John Brooks' death in 1935.

In an article written in the History of Williamson County, Texas by Tylene Edmiston: Thomas Holland Lindsey "was known for his bravery and strict obedience to the law. The Texas Rangers stayed in his home on several occasions. His barn concealed their horses and the Rangers themselves slept on the dogtrot of his home."

Thomas Obediah Lindsey, son of James Marion Lindsey, related the following in 1962: "Thomas H. Lindsey, my second cousin, was known as "Red" Tom. He came from Mississippi in 1845 with other members of the Lindsey family. He eventually migrated to Williamson County, Texas, building a house a few yards off the Florence road. Tom Gray, husband of his daughter, Susan, built a two-story white frame house over the remains of the

old house. That house is still standing. His son, Thomas, married Ann Russell. Thomas, Jr. died September 6, 1961. His wife, Annie, died in a few weeks on September 27. They had two daughters, Mr. A.A. Howell of Florence and Mrs. W.H. Kirkpatrick of Dallas. Thomas Jr. and Annie are buried in the Florence Cemetery. One daughter, Sallie Grezella Lindsey, married Milton J. Hasty on November 8, 1893."

B. B. Mantooth enlisted in the Confederate Army May 9, 1862 and was discharged June, 1865. Served in Anderson Company "D", Hubberth Regiment, Walls Brigade & Walker Division 22 Texas Infantry, as a Private. His widow, Nancy, applied for a Widow's Pension Nov 4, 1920. Her pension was allowed from Sept. 1, 1920 till her death. She was living at Rt. 3, Winnsboro, Texas when she applied for the pension, having lived there one year and ten months. (Pension No. 37074)

History of 22nd Infantry Regiment -

"The 22nd Infantry Regiment was organized on March 10, 1862 in Polk County, Texas. The men that volunteered for service in the 22nd Infantry were from Livingston, Mason, Quitman,

Palestine and Tyler, Texas. Field officers were Colonel Richard B. Hubbard, Lieutenant Colonel John J. Canon, Lieutenant Colonel Elias E. Lott, and Major Benjamin F. Parkes. The 22nd Texas Infantry was attached to the 1st Brigade, commanded by Colonel Overton Young. 1st Brigade, Walker's Texas Division, Trans - Mississippi Department, The regiment saw action in Arkansas and Louisiana including the battle at Young's Point on June 7, 1863. Young's Point served as a vital supply depot for the Union army. As the Texans advanced across the fields, they saw Federal reinforcements arrive by transports supported by gunboats. Confederate efforts at Young's Point ended in failure. In March 1864, the 22nd Texas Infantry participated in the operations against the advance of the Federal Army, under General Banks, from Franklin, Louisiana. The 22nd Infantry also participated in the battles at Natchitoches, Louisiana on March 31, 1864 and Wilson's Farm, Louisiana on April 7, 1864. On April 8, 1864, arriving near Mansfield, General Walker formed his division in line of battle and awaited the advance of the enemy. They participated in the Battle of Pleasant Hill, Louisiana on April 9, 1864 against 35,000 Federal soldiers. The Confederate force was under 16,000. The Texans captured 21 pieces of artillery, over 3,000 prisoners and more than 200 wagons. The Confederate loss was severe with over 2,000 killed and wounded. The regiment participated in operations against Gen. Steele from Little Rock to Camden, Arkansas. The 22nd Infantry participated in engagements at Marks' Mills, Arkansas on April 15, 1864. At this engagement there were about 300 Confederate casualties, including kills, wounds, and MIAs, compared to the 1,500 Union losses. The men of the 22nd Texas Infantry fought bravely at the Battle of Jenkins Ferry, Arkansas on April 30, 1864. A private in Walker's Texas Division stated, "An incessant roar of musketry prevailed for about six hours. During this time the tide of battle ebbed and flowed, now advancing then retreating, but at no time did the ground fought over vary more than about 250 yards. Owing to the dense fog and dense clouds of smoke which hung in the thick woods, many times opposing lines could only be discovered by the flash of their muskets. Had we received reinforcements we could have destroyed the entire train and perhaps have captured the entire army. The Federal troops fought well and were handled in a masterly manner." The dead were buried by Confederate forces. One member of Walker's Texas Division stated, "Soon after the battle ended, a detail of men were employed in burying the dead. Armed with shovel, pickaxe, and spade, they proceeded along the battleground to complete this mournful task, which the enemy was unable to accomplish. The ground was thickly strewn with the ghastly and mangled forms. The effluvium from the swollen, festering forms was too horrible for human endurance. No conception of the imagination, no power of human language, could do justice to such a horrible scene." The regiment marched to Shreveport, Louisiana and then to Hempstead, Texas. The 22nd Texas Infantry disbanded before General Kirby Smith and General John Magruder surrendered the Trans-Mississippi forces on June 2, 1865 at Galveston, Texas. "

** Thomas H. Wheeler was living with Martha Frances Lindsey Panther and her family in the 1850 census of Cherokee Co., Texas. While the Wheeler family connection is not yet know, it is known that these children were born in Mississippi and it is likely the Wheeler family came to Texas with the Lindsey family from Mississippi about 1845. The parents of the Wheeler children perhaps died with others in the group as they camped on the Mississippi River. Thomas H. Wheeler would later marry Susan P. Lindsey on January 23, 1862 in Angelina County, Texas. Susan P. Lindsey was the niece of Martha Frances Lindsey Panter, her father, Thomas Jefferson Lindsey, Jr., being the brother of Martha Frances Lindsey Panter. Thomas Wheeler's sister, Barsheba, would later marry George Mantooth, son of Sam and Mary Netherton Mantooth in Angelina County, Texas. The Lindsey family had moved from Cherokee County, TX to Angelina County, Texas where the Mantooth families lived. There were several inter-marriages among the Lindsey/Brooks/Mantooth families.

When Susan Lindsey Wheeler's sister, Nancy Ellen Lindsey Mantooth, applied for her Confederate Widow's pension in 1920, Susan Lindsey Wheeler stated that "my husband (Thomas H. Wheeler) and I lived neighbors to applicant and her husband at the time both of them went to war at same time. I know that he and my dead husband Thos. H. Wheeler were

in thesince they joined till the close. They served about 3 years all told." This statement was taken in Henderson County, TX. Nancy's husband served in the Anderson Company "D", Hubberts Regiment, Walls Brigade and Walker Division 22 Texas Infantry. B.B. Mantooth and his wife, Nancy Lindsey Mantooth were living at Homer (Angelina County, TX) in the 1860 census; therefore, the Wheelers were possibly living nearby.

It is not known where or when Thomas H. Wheeler died; however, he is apparently not buried with his wife, who died in 1939, in Henderson County, Texas.

In the 1880 Census of Madison County, Texas, Thomas Shehorn was living near Basheba Lindsey Adams and James Marion Lindsey, the brother and sister to Francis Martha Lindsey. The house in which James Marion Lindsey lived was built in 1895 by him. In 1894 he and his family moved into a log home built by Milton Hasty. Will Hasty's wife, Winnie Conway and his son, Guss Hasty, bought it when Will died. Winnie lived with a daughter during her old age. It was located on the right side of Willy Lindsey's (son of Nealy Lindsey) house near Florence. He lived there one year before building his own house. The lumber for the house cost \$10 per thousand feet. The new house was composed a covered porch across the front, a large living room with a fireplace on the right front of the house, and bedroom on the left side of the front. In the left rear of the house, there was a long diningroom, with a small kitchen with wood stove in the right rear of the house. The house faced south. Jacob Smart Lindsey was born 21 January 1821 in Tuscaloosa County, Alabama. He was the son of Thomas Lindsey and Bathsheba Sudduth Lindsey. Thomas Lindsey and his family are listed in the 1830 Federal Census of Tuscaloosa County, but during the 1830's the family moved to Choctaw County, Mississippi, and are listed in the Federal Census of 1840 in Choctaw County. Unfortunately, the courthouse in Choctaw County burn about 1855, and few records of the family can be found in Mississippi.

On 13 June 1843, Jacob married Nancy Margaret Sudduth (born 18 August 1827) who was his first cousin. Nancy's father, Jared Smart Sudduth was a brother to Bathsheba Sudduth Lindsey. Jacob's son, Joseph Cone, stated in an article in a newspaper about 1905 that his parents were married in Alabama; however, no record of the marriage has been found. It is probable that the couple married in Choctaw County, Mississippi. Nancy was orphaned when she was about 10 years of age, and there are records in Tuscaloosa County regarding the estate of her parents, and they show that she was the wife of Jacob Lindsey. According to a family tradition, Nancy taught Jacob "his letters", or to read and write.

Jacob and Nancy's first two children were born in Mississippi, Phoebe born 15 June 1844, and James Thomas born 11 August 1845. The family came to Texas about 1846/47 and settled in Cherokee County. The next record of a child was the birth of John Jackson Lindsey, born 19 February, 1855. If there were children born during the period 1845-1855 none apparently survived, and no cemetery records have been found in either Mississippi or Texas.

It is not known when Jacob Smart Lindsey was ordained to preach. Baptist records in Mississippi have no record of Jacob. A record of Jacob being a pastor of a church is found in the 1868 Cherokee Baptist Association Minutes where Jacob is listed as Pastor of Been's Creek Baptist Church. While Jacob bought his first farm in Cherokee County in 1851, by 1857 he was living near Brownsboro in Henderson County as a daughter was buried in Old Rock Hill Cemetery in February 1857. In the Saline Association Minutes of 1867, Jacob is listed as pastor of Shiloh Church, Henderson County. In the period from 1871 until Jacob's death in 1882, Saline Baptist Association Minutes record a very active ministry for Jacob. He is listed as different times as being pastor of a number of churches, among them Unity Church, Athens; New York Church; Friendship Church, Brownsboro; Rock Hill Church, Brownsboro; Edom Church, Edom; and Bethel Church, Athens. Bethel Church is now the First Baptist Church of Athens. In 1880 Jacob was moderator of the Saline Baptist Association. According to one record, Jacob donated one acre of land in 1871 where the present Rock Hill Baptist Church is located.

J.J. Faulk in his "History of Henderson County" wrote about the early days of the Baptist Churches in Henderson County. About Bethel Church (Now F.B.C.) Athens he wrote: "In early days Uncle Jake Lindsey, 'a diamond in the rough' served the Baptist church here as minister more than any oher. I knew him for many, many years before he died; he was a good man, a good reasoner, and like Uncle Dick, he never got tired."

Jacob Lindsey also served his community as county commissioner in 1867 until removed by military authorities during reconstruction in 1869.

Jacob Smart Lindsey died suddenly 5 October 1882. According to family tradition, he came home about noon from a preaching trip and died at home just after noon. Two weeks earlier Jacob had attended the annual meeting of the Saline Baptist Association. The 1883 minutes of the Saline Association record the following memorial to Jacob:

Report of Committee on Obituaries

"We, your Committee on Obituaries, would report that we are called to record the death of one of our body since we last met. Brother J. S. Lindsey has in the providence of an all-wise Ruler, been called to his reward. He departed this life October 5, 1882. While we feel that in the death

of Brother Lindsey, we have lost a brother of the most untiring energy and zeal in our Master's cause, and one held in high esteem by our body, yet, with humble submission, we bow to the will of Him 'who doeth all things well.' And as his companion and family have been called upon to bear this sore affliction, there be it Resolved, that we join them in sympathy and pray God that he will, for Christ's sake, bless and sanctify this great affliction to their eternal good. Respectfully submitted."

Jacob was buried in the Old Rock Hill Cemtery near his parents and some of his children, and his estate was probated in Henderson County. His wife and family remained in Henderson County for a year years, but moved west to Eastland County. Nancy Margaret Sudduth Lindsey died 17 November 1893 and is buried in Howard Cemetery near Desdemona, Texas.

Jacob and Nancy had two daughters and four sons who lived to be adults. Their eldest son, James Thomas Lindsey served in the Confederate army and died while in service 7 May 1864. The eldest daughter, Phoebe, married Thomas Clark. Phoebe apparently died in childbirth in 1881 and was survived by three sons. John Jackson Lindsey married Laura Powers and died in Lamesa, Texas, in 1918. Porter K. Lindsey died in Abilene, Texas in 1926. Joseph and Elizabeth's son who was also named Jacob Smart Lindsey was killed in action in France in 1918. Joseph was survived by four daughters. The last surviving child of Jacob and Nancy was Margaret Burleson Lindsey who was married first to J.A. Browning. Two of her children are buried in the Old Rock Hill Cemetery. She later married George Kaufman. She died in 1941."

According to Norman Dingmore:

JSL moved from Tuscaloosa County, Alabama to Cherokee County, Mississippi. See Tuscaloosa County records for a land sale of his wife's estate. Moved to Texas about 1847/48 to Cherokee County, Texas. Moved to Henderon County, TX in late 1850's per dates on children's grave stones. he was an ordained Baptist preacher. Pastorates: Bethel Baptist Church (now First Baptist Church-Athens). Bethel was located on site where Athene public library is now located. Rock Hill Baptist Church; Edem Baptist Church; New York Baptist Church. Buried in Old Rock Hill Cemetery which is near Brownsboro, Texas. Sources: J.C. Lindsey family Bible. Cemetery Records, old Rock Hill Cemetery; Census records, 1850, 1860, 1870 and 1880. family list made by Lavine Elizabeth Jenkins Lindsey (daughter-in-law); Tuscaloosa County, Alabama, Probate records. His probate is filed in Henderson County, Texas. George W. Panther and his future wife, Martha Frances Lindsey were both born in Alabama. The

Lindsey family moved to Mississippi about 1834, perhaps with members of the Panther family. George and Martha Frances married about 1844, probably in Mississippi. It is believed that George Washington Panther brought his family to Texas about the time the Lindsey family left Mississippi and settled in Cherokee Co., Texas. It is interesting to note that there were four young Wheeler children, all born in Mississippi, living with the Panther family in the 1850 census, shown below. Thomas H. Wheeler would later marry Martha Frances Lindsey. Panther's niece, Susan P. Lindsey, daughter of her brother, Thomas Jefferson Lindsey. Barsheba Wheeler would marry George Mantooth in Angelina County, Texas, where the Lindsey families later moved.
