**Washington Co. Deed Book E-1 (FHL microfilm # 1449139) has the 1778 inventory of the estate of Widow Lindsay. Samuel Brice and Joseph Ross were the appraisers. It appears that Widow was mis-transcribed as William in the court record.

*** The 1785 date may only be for the certificate, but I don't have any other dates for this service.
