first of all I recommend my soul into the hands of all-mighty God who gave it not Doubting but that at the general Resurrection it will be again united 2 I desire that all my just debts may be paid 3 I Recommend my body to the Earth to be buried in a decent & Christon burial at the Expence of my Executors & of all such worldly Estates as God has been pleased to bless me with in this Life I Desire to be Disposed of in the following manner Viz

- 4 I will beqeth Unto My father & Mother Isaac & Rachal Linsay my best feather b bed & furniture one peded Cow with her Young Calf all so all my puter & shelf furniture allso some small pots frying pan & baking pan & one Large wash pots allso one set of fire Doggs & one pare of tongs & fier shovel & poker allso one walnut Chest 5 I will & bequeth to father Isaak Linsa the smallest Black suit of waxing apparal of mine 6 I will & bequeth to Eda Parker my Second feather bed & firniture allso one womans saddle allso one five gallon pot thats new in her possession 7 I will & bequeth to my brother Thomas Putman one brown bay mare & my Riding Saddle 8 I will & bequeth to my nephew John Linsa Parker one branded & peded heifir yearling 9 I will & bequeth to my Sister Eda Parker twenty one Dollars of my vandue Notes 10 I will & bequeth to archabald Linsa ten Dollars 11 I will & bequeth to Ellender Linsa ten dollars also one oven & small chest 12 I will & bequeth unto my brothers Elisha and Jacob Linsa fifty Dollars Each to paid out of the notes Due to me from Archabald Linsey 13 I will & bequeth to my sister Drusiller Willson thirty Dollars to be paid out of the

money Due to me from Archabald Linsy 14 I will & bequeth all  
 the Rest of Estate after my Debts are paid all Expences is  
 paid to be Equally divided betwen My father Isaac Linsy and  
 Elisha Linsy & Jacob Linsy & Eda Parker & fanna Putman &  
 Drusiller Willson & Do hereby Revoke all former wills by  
 me made & Constitute & ordain this my last will & testament.  
 I also Anominate Elisha Linsa and Thomas Putman Executors  
 to this my last will & testament
